# INVESTMENT BANKING GRADUATE PROGRAMS AND INTERNSHIPS IN SPAIN 2012 GUIDE

This guide is specifically designed for Spanish undergraduate students who want to develop their professional career in the field of investment banking. The graduate programs and internships listed in this document are all placed in Madrid. You can check the websites provided for programs and internships in other locations.

The spring internships are designed for  $1^{\rm st}$  and  $2^{\rm nd}$  year students. The summer internships are directed to  $3^{\rm rd}$  (penultimate) year students. The offcycle internships are generally for both  $3^{\rm rd}$  and  $4^{\rm th}$  year students. The graduate (analyst) programs are for senior (ultimate) year students – these are not internships but job offers for graduates and do not require professional experience. Most investment banks also offer associate programs on their web sites – these are specifically designed for master students.

Most investment banks do not require finance or economics degree and are more interested in students who are able to prove deep interest in the field of finance. Investment banks highly value previous internships and extra-curricular activities such as membership in societies/associations, participation in conferences and trading competitions or additional finance courses. Some banks might ask you for your academic transcripts but generally banks require 2:1 according to the UK grading system, which correspond to about 7.0 in the Spanish system. Fluency in English is mandatory.

Please do not forget that your CV must not exceed one page. Motivation letters are also often required. Such letters must include your reasons for applying for this specific bank and this specific division, as well as an explanation of how your abilities and experiences make you the perfect candidate. Motivation letters should also not exceed one page.

Completion of numerical online tests and in some cases verbal-reasoning or abstract tests are often an important part of the selection process. If you want to practice your skills, you can, for example, register for free to <a href="http://www.shldirect.com/">http://www.shldirect.com/</a>. Apart from competence tests, application forms often include questions that require you to explain what the competitive advantages of the given bank are, describe situations where you demonstrated leadership or teamwork abilities, as well as to answer questions about current developments in the industry. Recruitment processes also often include telephone interviews, workshops and assessment centers.

Most investment banks recruit on a rolling basis so it is in your best interest to apply as soon as possible.

#### Requirements:

Candidates should be graduating in 2012. Candidates who have graduated in 2011 will also be considered.

Fluent written and spoken English and Spanish

Strong A-level grades (i.e. modules where you have earned more than 9.0) and on track for a minimum 2:1 average degree grade (i.e. an average of at least 7.0). Applications are accepted from a diverse range of degree disciplines such as the arts and humanities, as well as numerically focused subjects such as economics and mathematics

Candidates should be in their penultimate year of study, expecting to graduate in 2013

#### **Recruitment Process:**

- Stage 1: Part 1 of the Online Application Form
- Stage 2: Online Numerical Reasoning Test
- Stage 3: Part 2 of the Online Application Form (for those who meet or exceed the minimum numerical reasoning requirement)
- Stage 4: Your application will be reviewed and successful applicants will be invited to attend an Assessment Centre

Applicants may be requested to attend further interviews. You will only be able to apply to one vacancy.

# **Barclays Capital**

#### **Recruitment Process:**

Recruitment begins on 1 August 2011. Barclays Capital recruits on a rolling basis, so it's best to apply as early as possible. Deadline 30th December 2011. You'll be asked to fill in a short application form, upload a 1-page CV, and successfully complete numerical and verbal reasoning tests.

Barclays Capital encourages candidates to apply to one region; however, some roles recruit on a global basis. If applying for internships, Barclays recommend that students apply to the region that they would want to be recruited for a full-time role.

Candidates must decide between Barclays Capital and Barclays Wealth. They may not apply to both, although they can apply to Barclays in addition to either Barclays Capital or Barclays Wealth.

Most internships are offered to penultimate-year university students; however, there are certain circumstances where Barclays Capital would assess a graduate (4<sup>th</sup> year) student as well.

Barclays Capital expects applicants to have demonstrated strong academic performance at school and at college/university, although they don't have specific grade criteria for applicants.

GMAT: Not all schools require a GMAT for entry; therefore, it is not an essential part of the qualifications for entry. However, experience has shown that successful graduates in the firm are those whose GMAT score was 680 or higher.

#### **Recruitment Process:**

You can apply to up to two business divisions e.g. Institutional Clients Group (ICG) and Corporate Functions, but please stick to one vacancy within each. So for EMEA that means two roles are allowed.

The full-time recruitment process starts in the late summer so you will want to apply early in September. The summer recruitment process starts in the winter so you will want to apply in December.

While academic achievement is very important, Citi are also interested in students' extra-curricular activities and enthusiasm to work in the financial services industry and at the bank.

If you are applying for Citi's full time opportunities, then relevant work experience would certainly be an advantage. For Citi's summer internship program, applicants are not expected to have relevant work experience.

If you apply for investment banking and global markets and you're selected for first-round interviews, you will have two (for internships) or three (for full-time positions) one-on-one interviews, which will involve a case study. During the final rounds, you will have four 30-minute, one-on-one interviews with senior business representatives (a banker who is an Executive director or above). If you apply for corporate infrastructure, the first-round interview stage will be held at an assessment centre, consisting of two one-on-one, 30-minute competency-based interviews, as well as numerical tests and group exercises


